Sealed bids will be received by the Wayne County Board of Commissioners until 2:00 p.m., on January 9, 2018 for the **Parallel Taxiway Division II – Airfield Electrical, Phase I & IIa** project at the William A. Zorn Airport. Proposals received after the designated time will not be considered.

The bids will be publicly opened by the Wayne County Manager in the Commissioner's Meeting Room located at 341 East Walnut Street, Jesup, Georgia and read aloud.

The Contractor's Proposal will include the furnishing of all labor, materials, equipment and all things necessary pursuant to Drawings, Specifications and Conditions, etc., for the Contract.

The project generally includes the installation of airfield lighting and guidance signs along a parallel taxiway. The work generally includes installation of underground electrical cable, taxiway edgelights and guidance signs.

No Proposal will be considered unless accompanied by a certified check or acceptable Bid Bond in an amount not less than five percent (5%) of the bid amount and made payable to the Wayne County Board of Commissioners.

All bids must be made out on the separate proposal form furnished with the Contract Documents in accordance with the instructions in the Instructions to Bidders. No interlineations, additions or deletions shall be made in the Proposal form by the bidder.

Successful Bidder shall be required to furnish a Contract Performance Bond and a Payment Bond, each equal to 100% of the Contract Price, with the terms and surety to be approved by the Owner; and furnish satisfactory proof of carriage of the insurance required.

The Owner reserves the right, with or without notice or cause to accept any bid regardless of the amount thereof; to reject any bid, any number of bids; to negotiate with any bidder for a reduction or alteration in its bid; to waive or insist upon formal requirements; to reject all bids and to call for additional bids upon the same or different invitation to bid, Plans and Specifications; to be the sole judge, in its discretion, of all questions as to whether or not a bid complies with the Invitation to Bid, the Plans or Specifications, and as to the qualifications of a bidder to perform the Contract.

Bidders shall inform themselves concerning Georgia laws and comply with same.

No bidder may withdraw his bid within 120 days after the actual date of the opening thereof.
